### PREVENTION:

# Cherry Odor Control

**CHERRY ODOR CONTROL** is a fresh, new approach to the difficult problem of controlling offensive odors in sewage plants, lagoons, aerators, sewer mains and laterals and for garbage and refuse containers, haulers and dumps. **CHERRY ODOR CONTROL** effectively neutralizes odors without affecting bacterial action in digesters, lagoons, filter beds, septic tanks or drain fields.

### DIRECTIONS:

To control odors in aerators, lagoons, open digestors and filter beds, inject undiluted **CHERRY ODOR CONTROL** into the line leading to the source of odor. The amount of **CHERRY ODOR CONTROL** injected will vary with temperature, air movement and intensity of odor to be controlled. Another method is to use equipment to spray or mist undiluted **CHERRY ODOR CONTROL** over the source of odors, allowing air motion to carry it over the area, mixing it with the odors, vapors or fumes.

To control odors in sewer mains and laterals, pour, spray or drip undiluted **CHERRY ODOR CONTROL** into the lines. Also thoroughly spray manholes and drains.

For garbage and refuse containers, trucks and dumps, spray or drip undiluted **CHERRY ODOR CONTROL** liberally over the source of odors. Deodorize the containers, conveyors and trucks regularly, using **CHERRY ODOR CONTROL**.
