DANGER

Use caution when applying to synthetic surfaces that may be damaged by solvents, such as rubber, asphalt tile, some paints and certain plastics. Before using on a large area, test surface by spraying in an inconspicuous place.



DANGER:

PREVENTION:

RESPONSE:

IF SWALLOWED: DO NOT induce vomiting. Keep at rest. Get prompt medical attention.

IF ON SKIN: Flush with large amounts of water; use soap if available. Remove grossly contaminated clothing, including shoes, and launder before reuse.

IF INHALED: Using proper respiratory protection, immediately remove the affected victim from exposure. Administer artificial respiration if breathing is stopped. Keep at rest. Call for prompt medical attention.

IF IN EYES: Flush eyes with large amounts of water until irritation subsides. If irritation persists, get medical attention.

Store locked up.

DIRECTIONS:

Spray directly on mark from 8 to 12 inches, or spray onto a cloth and rub onto mark. Allow several minutes to penetrate, then wipe with a clean cloth. Difficult marks may require a second application or a longer time to loosen mark. On porous surfaces, scrub with a stiff bristle brush before wiping dry.
