This product is a phosphate free formulation designed to provide effective deaning, deodorization, and disinfection specifically for hospitals, nursing homes, schools, food processing plants, food service establishments, transportation terminals, automotive garages, office buildings, manufacturing facilities, lodging establishments, retail businesses, athletic/recreational facilities, sports stadiums, amphitheaters, convention centers, and households where housekeeping is of prime importance in controlling the hazard of cross contamination.

This product for use in: Health clubs, spas, tannings spas (salons), massage/facial salons, hair/nail/pedicure salons, barber/beauty shops, tattoo parlors.

When used as directed, this product is formulated to disinfect hard, non-porous, inanimate, environmental surfaces: floors, walls, metal surfaces, stainless steel surfaces, glazed porcelain, glazed ceramic tile, plastic surfaces, vinyl, chrome, bathrooms, shower stalls, shower doors, bathtubs, toilets, bathroom fixtures, kitchens, countertops, sinks, exteriors of microwaves, refrigerators, stoves, and other kitchen appliances, stovetops, automobile interiors, cabinets, tables, chairs, desks, dining room surfaces, doorknobs, garbage cans and telephones. For larger areas: operating rooms, patient care facilities and restrooms, this product is designed to provide both general cleaning and disinfecting.

This product, when used as directed, is formulated to disinfect the following hard non-porous infanimate environmental surfaces: Large inflatable non-porous plastic (rubber) (advertising) structures: alimals, promotional items, moonwalks, slides, obstacle course play equipment, exercise equipment, exercise mats. wrestling mats.

This product deodorizes those areas which generally are hard to keep fresh smelling, such as garbage storage areas, empty garbage bins and cars, toilet bowls, behind and under sinks and other areas where bacterial growth can cause malodors.

This product is a non-abrasive (non-scratch) cleaner for showers, tubs, shower doors, vinyl and plastic shower curtains, fixtures and toilet bowls.

To disinfect food processing premises: Before using this product, food products and packaging materials must be removed from the area or carefully protected. For floors, walls, and storage areas add 2 ounces of this product per aglian or water. For heavily soiled areas, a pre-cleaning step is required. *VIRUCIDAL ACTIVITY - This product, when used on environmental, inanimate, hard, non-porous surfaces at 2 ounces her gallon of water, exhibits effective virucidal activity against Influenza A2/Japan (representative of the common floyins), Herpes Sympley Type I (causative agent of upges - espiratory infections), werdina virus (representative of the Pox virus group), Human Coronavirus (ATCC VR-740, Strain 229E), Human Immunodeficiency Virus Type I (HIV-I), Hepatitis B Virus (HBV), Hepatitis C Virus (HCV), Norobiuse (Norvalk virus), Bovine Viral Diarrhea Virus (BVDV), Feline calicivirus (FCV), SARS Associated Goonavirus, Porcine Respiratory & Reproductive Syndrome Virus (PRRSV) (Strain AVS) Jand Avian Influenza & Follow the Disinfection directions.

At 8 ounces per gallon or equivalent dilution rate, this product is effective against the following viruses on fard non-porous environmental surface with 10 minute contact time: Canine Parovirus (CPV), Canine Adenovirus, Canine Coronavirus, Canine Parainfiluenza Virus, Feline Pinenteracheitis, Feline Oronavirus, Feline Picornavirus and Porcine Parovirus.

Canine Parvovirus (CPV) Activity: At 8 ounces per gallon of water or equivalent dilution, this product inactivates Canine Parvovirus (CPV) on hard, non-porous, environmental surfaces in the presence of 5% blood serum with a 10 minute product of time.

PERSONAL PROTECTION: When handling items soiled with blood or body fluids, use disposable latex gloves, gowns, masks, and eye coverings.

CLEANING PROCEDURES: Blood and other body fluids must be thoroughly cleaned from surfaces and objects before application of this product

CONTACT TIME: Allow surface to remain wet for 10 minutes

DISPOSAL OF INFECTIOUS MATERIALS: Blood and other body fluids should be autoclaved and disposed o according to local regulations for infectious waste disposal.

EFFICACY TESTS HAVE DEMONSTRATED THAT THIS PRODUCT IS AN EFFECTIVE BACTERICIDE, FUNGICIDE, AND VIRUCIDE IN THE PRESENCE OF ORGANIC SOIL (5% BLOOD SERUM).

MILDEWSTAT - To control mold and mildew on pre-cleaned, hard, non-porous surfaces, add 2 ounces of this product per gallon of water. Apply solution with a mop, cloth, sponge, hand pump trigger sprayer or low pressure coarse sprayer making sure to wet all surfaces completely. Let air dry. Prepare a fresh solution for each use. Repeat apolication at weekly intervals or when mildew growth appears.

To Control Mold and Mildew on Large, Inflatable, Non-Porous Plastic and Rubber Structures (animals, promotional items, moonwalk, sildes, obstacle course play equipment, exercise equipment, and wrestling masts): Thoroughly clean all surfaces with soap or detergent and rinse with water. Saturate surfaces with a use-solution of 8 ounces of this product per 4 gallons of water for a period of 10 minutes. Ventilate buildings and other closed spaces. Do not use equipment until treatment has been absorbed, set or closed.

GENERAL CLEANING - Apply this product to soiled area with a mop, doth, sponge, hand pump trigger sprayer or low pressure coarse sprayer. This product can be diluted at 2 ounces per gallon or applied at full strength. Thoroughly wet soiled surfaces and scrub as necessary.

DEODORIZATION - To deodorize, apply this product as indicated under the heading DISINFECTION.

APPLICATIONS AND USE DILUTION

Poultry and Swine Premise Disinfection Special Instructions for Inactivating Avian Influenza A: Remove all poultry or swine and feeds from premises, trucks, cars, coops and crates. Remove all litter, droppings and manure from floors, walls and surfaces of facilities occupied or traversed by poultry or swine. Empty all troughs, racks and other feeding and watering appliances. Thoroughly dean all surfaces with soap or detergent and rinse with water. Use 2 ounces of this product per gallon of water. Saturate surfaces with the recommended disinfecting solution for a period of 10 minutes. Ventilate buildings, coops and other closed spaces. Do not house poultry or swine or employ equipment until treatment has been absorbed, set or dried. Thoroughly scrub treated feed racks, troughs, automatic feeders, fountains and waterers with soap or detergent, and rinse with potable water before reuse. Immerse all halters, ropes, and other types of equipment used in handling and restraining poultry or swine, as well as forks, shovels, and scrapers used for removing litter and manure.

Hatcheries: Use 2 ounces of this product per gallon of water to treat the following hard non-porous surfaces: hatchers, setters, trays, racks, carts, sexing tables, delivery trucks and other hard surfaces. Leave all treated surfaces exposed to disinfectant solution wet for 10 minutes or more. Rinse with potable water before reuse. Then allow to air dry. For heavily soiled areas, a pre-cleaning step is required.

STORAGE AND DISPOSAL

DO NOT CONTAMINATE WATER FOOD OR FEED BY STORAGE OR DISPOSAL

PESTICIDE STORAGE - Store in a dry place no lower in temperature than 50 °F or higher than 120 °F.

CONTAINER DISPOSAL – Nonrefillable container. Do not reuse or refill this container. Offer for recycling, if available. Triple rinse container promptly after emptying. Triple rinse as follows: Fill container |1/4 full with water and recap. Agitate vigorously. Follow Pesticide Disposal Instructions for rinsate disposal. Drain for 10 seconds after the flow begins to drip. Repeat procedure two more times. Then offer for recycling or reconditioning. If not available, puncture and dispose in a sanitary landfill.
